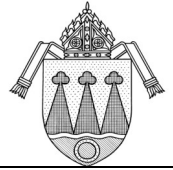

PART II — PETITION FOR PERMISSION MIXED RELIGION MARRIAGE

PART IV — PETITION FOR DISPENSATION FROM DISPARITY OF CULT

The Catholic Church declares an impediment to exist which prevents a valid marriage between a baptized Catholic and an unbaptized person. Because of this ecclesiastical law, the Catholic Party must ask for a dispensation. The following explanation may be helpful:

The concern of the Church, and the reason for maintaining the impediment of Disparity of Cult, relates to the fact that the marriage is not a sacrament when one of the Parties is unbaptized, but a natural bond. This may place an added strain on both the faith of the Catholic Party and the marriage bond itself. The preparing minister needs to address these issues in the marriage preparation, and encourage the Parties to explore how they will respect each other's faith stance in the marriage.

The petition must be received **no less than six weeks** prior to the anticipated wedding date.

The dispensation from form is only to be requested when one party is not Catholic and the wedding will not take place in a Catholic church, chapel or oratory, and it will not be celebrated by a Catholic clergyman. The dispensation must originate in the parish and diocese where the Catholic party has domicile or quasi-domicile, regardless of the city or diocese where the ceremony takes place. The prenuptial file remains in the originating parish and the marriage is to be recorded in the Marriage Register of that parish.
